2. Make sure that you have read and understood the mark scheme and the question paper for this unit. These are available in RM Assessor.

**MARKING**

1. Mark strictly to the mark scheme.

Once the level is located, award the higher or lower mark:

**The higher mark** should be awarded where the level descriptor has been evidenced and all aspects of the communication statement (in *italics*) have been met.

**The lower mark** should be awarded where the level descriptor has been evidenced but aspects of the communication statement (in *italics*) are missing.

**In summary:**

**The skills and science content determines the level.**

**The communication statement determines the mark within a level.**
